Comments: Page Two: Proposal states, "The team of LaKendra Brown (MPS teacher/school coordinator), Shawon LeFlore-Turnch (MPS teacher/school coordinator), Cheryl Isabell (school resource coordinator), LaVonda Stewart Whitley (MPS teacher), Rosalyn Washington (retired MPS teacher), Makeba Coleman (parent/community member), Judy Hemphill (parent/community member), Martina Stevens (community member), Tracey Nix, PhD (community member), Kayla Isabell, MSW (community member), and an advising administrator selected by the Marian Wright Edelman Community School Board of Directors, along with additional teachers, parents, community members, and business partners are seeking charter school status."

This team consists of the three educational leaders, as well as the advising administrator, whose experience and licensure includes regular education and special education. LaKendra Brown will address and assist with charter contract issues, and attendance. Both she and La Vonda Stewart Whitley will address issues regarding special education and compliance. Shawon LeFlore-Turnch will address and assist with student behavior and management, parent

concerns, school-wide discipline, and coordinating transportation."

Comments: Page Twelve: Proposal states, "All teachers, paraprofessionals, and support staff working at The Marian Wright Edelman Community School will be employees of the Milwaukee Board of School Directors. The ELT will assign teachers and support staff to positions that are in accordance with their DPI licensure. Paraprofessionals will meet all hiring requirements of the District. They shall be represented by and subject to provisions, including wages and benefits, of existing Milwaukee Public Schools handbook agreements. Pre-employment and employment functions and/or all actions related to and required for hiring will be operated under the direction of the MPS Department of Human Capital."

 Comments: Page Twelve: Proposal states, "Safety policies and procedures will follow MPS

protocols. Fire, Tornado, and Emergency (Code Red, Yellow, Green, and Blue) drills will be conducted according to MPD guidelines. In the event of an emergency which requires evacuation, the students and staff of The Marian Wright Edelman Community School will be securely relocated to the Milwaukee College Prep/YMCA, 1350 West North Avenue. The Marian Wright Edelman Community School Crisis Plan will be established, in accordance with all district procedures and guidelines. All staff members will be able to execute the plan in the event of an emergency...The school social worker will provide annual training to all staff members on how to detect and properly report suspected cases of child abuse and neglect. The school nurse will provide services as defined in the realm of duties identified by MPS...The implementation of Ma'at (culturally responsive behavior management) will contribute to maintaining a safe learning environment. All students will be supported through tier 1 supports, which include but are not limited modeling appropriate behaviors and recognition. Individual students who need additional supports, will be monitored through tier 2 mentoring. Students who need additional tier 3 supports will be working with the school community through restorative practices. The MPS health curriculum, as well as resources from Children's Hospital of Wisconsin, will also be used to assist in the development and management of safe and healthy attitudes and practices among all students. All antibullying policies adopted by the District will be strictly enforced. The Marian Wright Edelman Community School will also seek community resources that will encourage students and their families to adopt and/or maintaining healthy lifestyles."

For example, the Marian Wright Edelman Community School seeks to use curriculum elements for literacy instruction outside of the curriculum utilized by the District.

The Panel would have liked to have seen more information relating to promotion requirements, particularly as relates to grades four and eight. Additionally, the Panel would have liked to have seen more information about addressing

advanced students as well as those lagging behind.

Comments: Page Nine through Ten. The Panel determined the method for student assessment is well elaborated and relates to both curriculum and instructional methods as well as state and district standards.

- **0** (1) 2 3 19. The manner in which administrative services will be provided
 - Comments: Page Eleven. The Panel felt there was a lack of clarity in the connectedness between the Board of Directors (BOD), School Governance Council (SGC), Educational Leadership Team (ELT), and the Parent Teacher Association (PTA). Moreover, the Panel was concerned with the teacher leaders' desire to hold permanent positions on the BOD. The Panel would have liked to have seen more mention of community as it relates to the governance structure. The Panel questions if the presence of the administrative advisor one day per week will be enough to provide the necessary administrative services although the school seeks to be teacher led. The panel recommended the option of using a retired principal through a Limited Term Employment (LTE) contract to fill the part-time administrative role.

 - o Governance structure is clearly defined-
 - o Governance structure reflects diversity in school community supports
 - o Parent involvement is evident in the school governance structure

Comments: Page Ten through Eleven. The Panel determined the school governance structure was vaguely communicated. The Panel would have liked to have seen more information about parental involvement, particularly as it relates to parental input in the planning of the school (e.g. polling the neighborhood for their input on opening the school). The Panel also would have liked to have seen more information about specific strategies for parental and community involvement (e.g. parent education, focus groups, etc.). Additionally, the Panel noted that although the District currently uses the Epstein framework for community involvement, the school that the teacher leaders come from does not, so implementation would be new to them.

 - Comments: Page Thirteen and Appendix E. The Panel determined that the culturally responsive teaching model is a cornerstone for embracing diversity. They also noted that the city wide busing that the school aims to provide promotes diversity. The Panel would have liked to have seen a more developed strategy for educating English as a Second Language students.

Comments: Page Fourteen and Appendix H. The Panel determined that the method for disciplining students is underdeveloped. The Panel would have liked to have seen more organized and elaborated information on the compatibility between the MPS discipline policy and Ma'at concepts.

Comments: Page Fifteen. The Panel determined that a facility has been identified by the school. The Panel acknowledged the community around the facility was taken into account in the development of the educational concept. The Panel would have liked to have seen more information about how the school will use the facility.

Comments: This charter school petition provides an exceptional educational concept and meets the needs of the district while offering something new and innovative for students and families. Overall, the Panel is excited by the educational concept. They believe community partnerships will be critical to executing the concept's many components. The panel noted the passion and enthusiasm of the development team as well as the presence of research to support components of the educational concept. Despite confidence in the educational program, model of instruction, and measures of assessment, the Panel expressed reservations in the areas of school administration, governance structure, and student discipline. The Panel noted a lack of clarity in these areas. While the Panel does not recommend the proposal be considered for an MPS charter school at this time, the Panel highly encourages the development team to resubmit with modifications at a later date.
